## RoHS and REACH Compliance Declaration

Dear Valued Customer,

TouchPoint Medical and iTD Corporation are dedicated to serving you by providing high quality, innovative and intelligent solutions that enable safe and effective delivery of outstanding patient care that meet environmental regulations, including EU Directive 2002/95/EC and subsequent amendments of the European Parliament and of the Council of the use of certain hazardous substances in electrical and electronic equipment (EEE) and REACH (Registration, Authorisation and Restriction of Chemicals, European Union Regulation (EC) 1907/2006). We are providing you the following information to assist you in meeting your environmental policies and procedures.

### RoHS Compliance

- We produce parts that are RoHS compliant with the RoHS Directive (EU Directive 2002/95/EC and subsequent amendments) are marked “RoHS Compliant.” RoHS Compliance means that the substances restricted by the EU Directive 2002/95/EC and subsequent amendments of the European Parliament are not contained in a finished product above the threshold limits stated unless the restrictive substance is subject of an exemption contained in the RoHS Directive. The Amendment to Annex II, dated March 31, 2015 additionally restricts the use of DEHP, BBP, DBP and DIBP in Electrical and electronic equipment and becomes effective **July 22, 2019**. TouchPoint Medical or iTD Corporation cannot guarantee that inventory held by distributors or other third parts is RoHS compliant.
- The compliance of our products with RoHS is affected through:
  - Strictly controlling the materials and finishes that are used in our products
  - Periodic audits of our suppliers to insure compliance
  - Periodic analysis, on an as-needed basis, of our products.

### RoHS – Recast

- Directive 2011/65/EU of the European Parliament and of the Council of June 8, 2011 on the restriction of the use of certain hazardous substances in electrical and electronic equipment (EEE) became effective on January 3, 2013. As a result, some of the provisions of Directive 2002/95/EU will be phased out and new provisions of the Directive 2011/65/EU will be phased in over time. We have an aggressive plan to meet all the requirements of RoHS – Recast.

## REACH Compliance

In June 2007, the European Union Regulation (EC) 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) was first released. This Regulation establishes specific duties and obligations for companies in the European Union (EU) that manufacture or import substances on their own, in preparations, or in articles.

- Under the structure of the REACH Regulation, TouchPoint Medical is a manufacturer and supplier of “articles” to our EU customers. We do not manufacture or supply “substances” or “preparations” and our articles do not involve the intentional “release of substances”. Accordingly, we foresee no registration or pre-registration requirement for the products we supply to you.
- TouchPoint Medical believes that even though REACH is an EU regulation, the TouchPoint Medical products are affected in all geographical regions. Therefore, TouchPoint Medical has put together a team to implement REACH on a worldwide basis.
- TouchPoint Medical is constantly monitoring the substances of very high concern (SVHCs), as defined by REACH, in our products. This will be an on-going process since the complete list of SVHCs will be released in stages.

- TouchPoint Medical products (articles) do not contain Substances of Very High Concern (SVHC) above the threshold value declared as per ECHA till March 5, 2018.
